## Having heard the rapporteur, Having deliberated in compliance with the law,

- Whereas the August 11, 2008 letter of Mr. KHUN SOPHAL and Mr. SAING VANNAK, requesting to withdraw their August 08, 2008 petition against the August 06, 2008 NEC Trial Jury's decision, made in accordance with the legal form, is therefore admissible;
- Whereas in accordance with the legal principle, the plaintiff has the right to withdraw entirely or partly his petition at any stage of the procedure;

## **Decides:**

- **Article 1 :** The August 11, 2008 petition of Mr. KHUN SOPHAL and Mr. SAING VANNAK is admissible for its legal form and substance.
- **Article 2**: Is upheld the August 06, 2008 NEC's decision, upholding the July 26, 2008 Kompong Thom Provincial Election Committee's decision.
- **Article 3**: The present decision made at the Constitutional Council Plenary Session in Phnom Penh, on August 13, 2008 shall be final, without recourse, shall have authority over all the instituted powers as stipulated in the Constitution and shall be published in the Royal Gazette.
