The Constitutional Council

- Seen the Constitution of the Kingdom of Cambodia;
- Seen Preah Reach Kram N° CS/RKM/0498/06 of April 08, 1998 on the Organization and the Functioning of the Constitutional Council;
- Seen the decision N° 035/001/2000 CC.D of January 28, 2000 of the Constitutional Council;
- Seen Preah Reach Kram N° CS/RKM/0300/06 of March 03, 2000 promulgating the Audit Law of the Kingdom of Cambodia;
- Seen the letter N° 916 NA dated August 14, 2006 from Samdech **HENG SAMRIN**, President of the National Assembly, requesting the Constitutional Council to examine the constitutionality of the Law on the Amendment of the Article 18 of the Audit Law of the Kingdom of Cambodia, letter received by the Secretariat General of the Constitutional Council on August 14, 2006 at 10.13 A.M;

Having heard the rapporteur,

Having deliberated in compliance with the law,

- Whereas following the Article 140 N, paragraph 2, sentence 1 of the Constitution which states that “*the Rules of Procedure of the National Assembly, the Rules of Procedure of the Senate, and all the Organic Laws shall be sent to the Constitutional Council for the review before their promulgation.*” the request N° 916NA dated August 14, 2006 from Samdech **HENG SAMRIN**, President of the National Assembly, received by the Secretariat General of the Constitutional Council on August 14, 2006 at 10.13A.M is in conformity with the Constitution, and therefore admissible;
- Whereas the National Assembly and the Senate have duly implemented the procedures stipulated in the Article 113N for examining and adopting the above-mentioned law;
- Whereas the substance of the Law on the amendment of the Article 18 of the Audit Law of the Kingdom of Cambodia does not contain any provision contrary to the Constitution;

Decides:

Article 1: The Law on the Amendment of the Article 18 of the Audit Law of the Kingdom of Cambodia adopted by the extraordinary session, of the third legislature of the National Assembly on July 27, 2006 and approved by the extraordinary session, of the second legislature of the Senate on August 09, 2006, is declared constitutional.

Article 2: This decision made in the plenary session of the Constitutional Council in Phnom Penh on August 18, 2006 shall be final without recourse, shall have authority over all the instituted powers as stipulated in the Constitution and shall be published in the “Journal Officiel”.
